INFORMATION CLAUSE

for the Participants of the XXVI International Seminar of Metrology

- 3. Personal data will be processed for the purpose of:
 - a) organization of the event, under Article 6(1)(e) of the GDPR including: registration of participation, handling of the event, contact with participants, including via the Internet, documentation and reporting of the course, release of post-conference materials, handling of correspondence, as well as issuance of certificates of participation *in connection with the implementation of the tasks and missions of the university in the field of education, scientific activity, shaping civic attitudes, as well as participation in development and the creation of an innovation-based economy;*
 - b) publishing in the case of obtaining positive scientific reviews, personal data of participants with a scientific article or poster may also be processed *for publishing purposes* under Article 6(1)(b) of the GDPR;
 - c) granting journalist accreditation under Article 6(1)(c) of the GDPR, when the processing is necessary to comply with a legal obligation to which the administrator is subject, in connection with the Press Law;
 - d) contact with persons reporting to the organizers under Article 6(1)(f) of the GDPR processing for the purpose resulting from legitimate interests, i.e. responding to questions and requests.
- 4. The administrator will process the image of the participants recorded in the form of photos and video recordings during the XXVI International Seminar of Metrology under Article 6(1)(a) of the GDPR, on the basis of the consent given, and under Article 6(1)(f) of the GDPR, i.e. within the legitimate interest of the administrator for the purposes of reporting, informing and promoting events related to the accomplishment of the commissioned task.
- 5. The provision of data is necessary to fulfil the purposes for which it was collected. Refusal is equivalent to not being able to participate in the event.
- 6. The recipients of personal data (image), mainly through live coverage, retransmission of the event, as well as media materials provided will be in particular: social networking sites Facebook, Youtube and Twitter, as well as television, Internet portals and newspapers publishing the coverage.
- 7. Personal data will be processed until:
 - a) completion and settlement of all activities related to the organization of the XXVI MSM (including the release of post-conference materials), or
 - b) withdrawal of the consent constituting the basis for this processing (applies to image processing), or
 - c) objection to the processing of your data;

and after this period, stored for the time and purpose, and to the extent required by law.

After the expiration of the retention period, this data will be irreversibly deleted.

- 8. Rights of the persons whose data we process:
 - a) to request access to the content of their data, rectification, deletion or restriction of processing,
 - b) to object to processing,
 - c) to data portability,

as long as the law allows it.

- 9. You have the right to lodge a complaint with the supervisory authority (i.e. the President of the Personal Data Protection Office).
- 10. Personal data will not be subjected to automated decision-making processes (including profiling).
