

# **TERMS AND CONDITIONS OF THE XXVI INTERNATIONAL SEMINAR OF METROLOGY "METHODS AND TECHNIQUES OF SIGNAL PROCESSING IN PHYSICAL MEASUREMENTS"**

## **§ 1 – Conference Organizer**

1. The organizer of the XXVI International Seminar of Metrology (hereinafter referred to as the "Conference") is the Department of Metrology and Diagnostic Systems of the Rzeszow University of Technology.

## **§ 2 – Rules of participation**

1. Participation in the Conference is paid. Detailed conditions and fees for participation in the Conference are available on the website <https://msm.prz.edu.pl/en/> the "Deadlines & Fees" tab.
2. The conference fee provided on the website applies to each conference participant individually.
3. The conference fee of PLN 2500/500€ includes participation in the conference and accompanying events, two nights in the Conference and Spa Center "Amer-Pol & Atrium" (38-610 Polańczyk, 28 Zdrojowa Street) in a double room with meals, bus travel on the route Rzeszów – Polańczyk and conference materials.
4. The fee does not include the optional publication in the Advances in Science and Technology Research Journal.
5. If you wish to publish an article in the Advances in Science and Technology Research Journal, you must go through the full review process and pay a fee of €370 (detailed information available on the <https://www.astrj.com> website).
6. Registration for the Conference takes place by filling in the form on the <https://msm.prz.edu.pl/en/registration> website. During registration, it is mandatory to provide all the data requested in the registration form.
7. Filling in the registration form is tantamount to accepting the regulations of the XXVI International Seminar of Metrology.
8. Registration will be open until the date specified on the conference website <https://msm.prz.edu.pl/en/> in the "Deadlines & Fees" tab. The Organizer reserves the right to extend the registration deadline.
9. The requirement for participation in the Conference is the registration referred to in §2 section 6 and the payment of the conference fee within the required period.
10. The Conference may be attended by a university researcher, engineer or any other person working for the development of fields of science related to metrology.

### § 3 – Resignation from participation

1. The Conference Participant who has registered has the right to completely resign from participation in the Conference without giving a reason, and is obliged to inform the Conference Organizer of this fact by September 8, 2025 at the latest <https://msm.prz.edu.pl/en/>.
2. If a registered Conference Participant does not place the fee within the set deadline – their registration will be automatically cancelled by the Organiser.

### § 4 – Image

1. By making the registration referred to in §2 section 6, the Conference Participant agrees to the free and unlimited in time and place use, dissemination and distribution of their image recorded by any technique on any media (including in the form of photographic film documentation) by the Personal Data Administrator, which is the Rzeszów University of Technology, with its head office at al.
